Guest Speaker Dr. LuAnn Holmes



Dr. LuAnn Holmes serves as the City Clerk for the City of Las Vegas, bringing over 26 years of experience in the public sector. In her role, she ensures that southern Nevada's local democratic processes adhere to state statutes, city charters, and local ordinances. Her responsibilities are wide-ranging, encompassing strategic and business management, technology implementation, records management, public meeting administration, and legal compliance. Dr. Holmes is also entrusted with overseeing municipal elections and preserving the city's historical documents and artifacts.

As City Clerk, Dr. Holmes directs the operations of the Office of the City Clerk (OCC) to ensure integrity and transparency within municipal governance. Under her leadership, the OCC manages three critical divisions: Administrative and Meeting Services, Election and Civic Engagement Services, and Enterprise Records Management. The OCC is responsible for maintaining public records, overseeing elections, and ensuring adherence to Nevada's Open Meeting Law, while offering legislative support to the City Council and numerous other public boards and committees.

Dr. Holmes is passionate about enhancing local democratic processes, particularly in areas such as public transparency, election integrity, and civic engagement. She is committed to ensuring that Las Vegas' diverse population has accessible and equitable pathways to participate in the democratic process. As the 2025 Nevada Legislative Session approaches, her office is focused on key policy areas including public records, elections, open meeting laws, and the protection of personally identifiable information.

Her dedication to public service and deep knowledge of procedural governance make Dr. Holmes a vital leader in maintaining the accountability and efficiency of Las Vegas' municipal government.

MEMBERSHIP RECRUITMENT AND GROWING OUR BRANCH

Let's grow our branch membership. Every member can be a recruiter. Most individuals join AAUW and other organizations because someone they know told them about the organization and invited them to a meeting or activity.

We challenge all our members to bring guests to our meetings and activities, so we can grow our membership with individuals who support the mission and work of AAUW.

MEMBERSHIP RENEWALS

Membership renewals now occur throughout the year. While most of our branch members have June 30 membership expiration dates, our newer members may have a membership renewal date that occurs in a different month. The Membership Directory included each member's renewal dates this year.

Beginning In April, members that have renewal dates of May and June will begin receiving monthly email notices from AAUW regarding renewing your membership. There will be a link to renew, using a credit card, or you may still send a check to our treasurer, Letti Dowell (see Letti's address below).

Members will begin receiving renewal notices approximately three months prior to their renewal date and will continue to receive them through the grace period, which is three months after the renewal date or until the member renews their membership. After the three-month grace period, members that have not renewed their membership are dropped from the membership.

All members with May – September renewal dates should be sure to renew their membership no later than August 31, to ensure that your membership does not lapse and so we can be sure to include you in our membership directory for 2024-2025.

Membership dues remain at \$98 for branch members, \$18.81 for student affiliate members and \$17 for Honorary Life Members.


Public Policy Evelyn Thompson-Hilbert

NEVADA

Nevada Question 6, Right to Abortion Initiative (2024)

Nevada Question 6, the Right to Abortion Initiative, is on the ballot in Nevada as an initiated constitutional amendment on November 5, 2024.

A "yes" vote supports providing for a state constitutional right to an abortion, providing for the state to regulate abortion after fetal viability, except where medically indicated to "protect the life or health of the pregnant patient."

A "no" vote opposes providing for a state constitutional right to an abortion.

National Policy Updates

With Congress returning from recess, Meghan Kessel (AAUW, National) discussed federal appropriations, Title IX, and the Equal Rights Amendment.

Gender Pay Gap

The U.S. Census Bureau has released new pay gap data. **Overall, women working full time in the U.S. make 84% of what men do. Collectively, working women lose out on more than \$500 billion a year.** The gender pay gap exists for every age group and widens over a woman's lifetime. It increases throughout a woman's work life and is widest for women ages 45–64.

The 2025 Equal Pay Day Calendar will be shared at the end of the year.

National is researching head-to-head voter guides for key congressional races: AZ-01, AZ-06, AZ Senate; IL-17; MI-10, MI-07, MI-08, MI Senate; PA-17, PA-10, PA-07, PA-08, PA Senate; WA-03; WI-03, WI Senate.

Completed guides are posted to the AAUW Action Fund website.

Equal Rights Amendment

The 14th Amendment ensures equality for MEN, but it remains silent on women.

According to Meghan, the Discharge Petition in Congress still needs to be four signatures short of the requisite number to have a vote. All the Democrats in the House of Representatives have signed the petition. We still need to encourage Republican members to sign to get this for a vote.

It's challenging to see the 118th Congress getting enough signatures to vote on this at this point in the political calendar. However, that is not the only path forward for the ERA. It's incumbent on all of us to keep educating our communities about gender not being in the U.S. Constitution.

We need to continue to build political will for Congress, the President, and ultimately the Archivist, to take action on this critical measure!

Colleges are slowly releasing demographic data for the Class of 2028, giving a glimpse of the Supreme Court ruling's impact on racial diversity. The results are decidedly mixed.
