## Women Inspiring Nevada Jenna Heath

## Director of Student and Community Engagement UNLV College of Liberal Arts

Jenna Heath built her career on the belief that education can transform lives. As director of student and community engagement for UNLV's College of Liberal Arts, she oversees programming that reaches nearly 4,000 students each semester and manages a \$28 million scholarship portfolio. She also leads the college's internship program, which connects more than 300 students annually with career-aligned opportunities through industry partnerships and advisory councils.

Her commitment extends beyond the university. Heath has raised thousands of dollars for local nonprofits, served on boards including the Crohn's & Colitis Foundation, and volunteers with Gamma Phi Beta sorority. In 2024, she launched Tearin' Up My Heart: Emotional Leadership Lessons, a podcast designed to help listeners understand the emotional side of leadership and make education more accessible.

As she pursues a Ph.D. in educational policy, Heath continues to mentor first-generation students, teach leadership development and champion inclusive, emotionally intelligent leadership. Heath's work brings her research into practice while empowering others to find confidence and purpose through education.

Louisiana v. Callais: Why This Supreme Court Case Matters for Voting Rights—and for Us On October 15th the U.S. Supreme Court heard Louisiana v. Callais, a case that could profoundly affect the future of voting rights in America—and the ability of communities to have fair representation in government.

After the 2020 Census, Louisiana adopted a congressional map that left Black voters—who make up about one-third of the state's population—with significant influence in only one of six districts. A federal court ruled this likely violated Section 2 of the Voting Rights Act (VRA) of 1965, which protects voters from racial discrimination. The court ordered the state to draw a new map with a second majority-Black district.

Soon after, opponents sued, arguing that this new map was unconstitutional because race played too large a role in its creation. The Supreme Court agreed to hear the case, asking a critical question:

Can states intentionally consider race to fix racial discrimination in voting—or does doing so itself violate the Constitution?

#### What's at Stake

The Court's decision could reshape how states draw voting districts across the country. If the justices rule against Louisiana's new map, it could weaken—or even dismantle—Section 2 of the Voting Rights Act, making it harder for communities of color to challenge maps that dilute their voting power.

#### **Why This Matters to Us**

AAUW has always championed equity, access, and representation. Fair voting systems are the foundation of progress on every issue AAUW cares about—education, pay equity, women's leadership, and equal opportunity.

When communities lose the power to elect officials who reflect their needs, the policies that shape our schools, workplaces, and neighborhoods become less equitable. The right to vote—and to have that vote count equally—is essential to achieving gender and racial justice.

#### What We Can Do

This case is about more than redistricting—it's about who gets heard in our democracy. AAUW members can take action by staying informed, supporting civic education, and engaging in discussions about fair representation in their communities.

As the Court prepares its decision, Louisiana v. Callais reminds us: equity cannot thrive without representation, and representation cannot exist without fair voting rights.

#### **Membership Renewals**

Membership renewals now occur throughout the year. While most of our branch members have June 30 membership expiration dates, our newer members may have a membership renewal date that occurs in a different month. The Membership Directory included each member's renewal dates this year.

You should receive an email notice from AAUW regarding renewing your membership. There will be a link to renew, using a credit card, or you may still send a check to our treasurer, Letti Dowell (see Letti's address below).

Members will begin receiving renewal notices approximately one month prior to their renewal date and will continue to receive them through the grace period, which is three months after the renewal date or until the member renews their membership. After the three-month grace period, members that have not renewed their membership are dropped from the membership.

All members with May – September renewal dates should be sure to renew their membership no later than August 31, to ensure that your membership does not lapse and so we can be sure to include you in our membership directory for 2025-2026.

Membership dues remain at \$100 for branch members, \$18.81 for student affiliate members and \$17 for Honorary Life Members.


